The public investment comes from the State, with 29 million budget of the Ministry of Women, or 0.007% of the budget of The state, the weaker. We have reached the status of "burnout", and are tired of associations that come up against the lack of resources. Rape, in France are not judges enough. There must be public money to fight these inequalities.

In some areas the means were abolished, their budgets for women. But private money is not in the culture of France.
